The Jack London Cove package is available every day except Tuesday. The space must be booked at least 14 days in advance but no more than six months.

### Jack London Cove Use Fees

- \$200 facility fee for up to three hours, Monday & Wednesday.
- \$300 facility fee for up to three hours, Thursday.
- \$500 facility fee for up to three hours, Friday - Sunday.

### Fees Include

- Exclusive use of designated space for three hours.
- Space includes banquette seating and chairs with tables inside, side door access to patio area featuring rail bar and couch area.
- Designated private bar access inside the taproom.
- Unlimited non-alcoholic beverages for all guests, featuring canned Pepsi products and iced tea.
- Servers and bussers are roving among guests taking orders and maintaining a clean event atmosphere.
- Audio Visual – includes choice of what is played on three television screens from taproom's satellite provider. Capable of running presentations on television monitors as well. Dust Bowl does not provide AV staff support. No outside audio may be brought in including karaoke.

### Capacity

The Patio Duo space rental is available Monday, Wednesday and Thursday only. The space must be booked at least 14 days in advance but no more than six months.

### Patio Duo Use Fees

No charge to reserve up to three hours, Monday & Wednesday.  
\$100 facility fee for up to three hours, Thursday.

### Fees Include

- Exclusive use of two, side-by-side long picnic-style tables located in the outside patio area. The tables are protected from the colder elements by clear, secure curtains.
- Servers and bussers are roving among guests taking orders and maintaining a clean event atmosphere.
- Overhead fans may be utilized during warmer weather.
- Audio Visual – includes choice of one television screen from taproom's satellite provider. Capable of running presentations on television monitor as well. Dust Bowl does not provide AV staff support. No outside audio may be brought in including karaoke.

The Ultimate Patio is available six days a week, excluding Tuesdays. The Ultimate Patio includes five picnic tables located in the Beer Garden just outside the taproom. The tables are protected from the colder elements by clear, secure curtains, which also create more privacy. Overhead fans may be utilized during warmer weather. The Ultimate Patio must be booked 14 days before the event date and no further than six months in advance.

### Ultimate Patio Use Fees

\$300 facility fee for up to three hours, Monday & Wednesday.

\$400 facility fee for up to three hours, Thursday.

\$600 facility fee for up to three hours, Friday, Saturday & Sunday.

Facility Fee - Non-refundable payment of facility fee serves to secure the event. The facility fee may be paid over the phone or in person.

Payment Options – Cash, check or credit card payable for the balance due at end of the event.

### Capacity

Total seated capacity of 60 guests. Max capacity of 75 guests including standing.

Half Buyouts are available seven days a week. The Half Buyout includes the Jack London Cove and Ultimate Patio spaces. Half Buyouts must be booked a minimum of 30 days prior to the event and not more than six months in advance.

### Half Buyout Use Fees

- \$500 – Monday & Wednesday for up to four hours.
- \$750 – Thursday for up to four hours.
- \$1,000 – Friday, Saturday & Sunday for up to four hours.

Facility Fee – Non-refundable payment of facility fee serves to secure the event. The facility fee may be paid over the phone or in person.

### Capacity

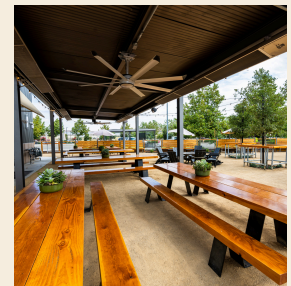
